# **APPLICATION METHODOLOGY**

#### **SURFACE PREPARATION**

Concrete - Mechanical grinding or other suitable surface preparation is recommended for obtaining best results on concrete. Compressed air is used to remove residual dust or use brush to remove dust completely. Compressed air should be oil free. Apply only to dry surfaces.

#### **STEEL**

Steel surface which are to receive FIBPOXY CTE coating should be prepared by power tool or mechanical cleaning to a commercial Grey metal finish. If moisture or other contaminants contaminate prepared surface, they should be regrind.

# **PRIMING**

Generally FIBPOXY CTE not need any primer, For highly absorbent surface use Eversil Primer.

# **MIXING**

Mix (by weight) 8.43 parts of Component A to 1 part of Component B by stirring thoroughly for at least 3 minutes. Allow the mix to stand for 10 minutes before application.

#### **APPLICATION**

For best results, apply two coats of FIBPOXY CTE by brush, roller or spray. First coat should be allowed to dry tack free before application of second coat. The second coat should be applied within 72 hours, wipe first coat with MIBK and wipe dry with cloth before second coat.

#### **CLEAN UP**

Clean all tools immediately after use with Fibrex Paint Remover. Do not allow material to harden.
